Dalhousie Mountain – Completed last December. Erector – KR Wind Rebar Contractor – Rendan Fabricators

Maryvale, Antigonish County – Small amount of windmills. Completed last December. Erector – KR Wind Rebar Contractor – Harris Rebar

Nutby Mountain – In progress. Erector – Enercon (German Contractor, manufacturer and fabricator) Rebar Contractor- Rendan Initially Enercon contracted the work in Port Hawksbury to a non-union company. We were able to persuade Enercon to award this contract to a Unionized Contractor. That led them to using us for Nutby Mountain and the Glendhu Project.

Digby Neck – In progress. Approximately 20 Windmills. Erector – Signal Wind Energy LLC (US Contractor) Rebar Contractor - Rendan.

Glendhu, Antigonish & Pictou County. Erector – Enercon (through Black & MacDonald) Rebar Contractor – Rendan (15) Greenfield Construction (12)

Wind Farms construction throughout Canada has been increasingly done by non-union companies. We have to continue working hard to keep Wind Farms Unionized in Nova Scotia!
